

APPLICATION TERMS AND CONDITIONS

1. APPLICATION - ACCEPTANCE FORM

The right to apply submission have galleries with their own showroom and continuous exhibition activity over time.

By sending the Application Form, the gallery expressly commits to its participation in Art Athina, if selected.

The application should be sent electronically no later than **February 23rd, 2024,** at exhibitors@art-athina.gr.

Only the applications containing all the required information and the corresponding supporting material will be reviewed by the Selection Committee.

Participation in the exhibition is decided by the Selection Committee. Responses for participation in Art Athina 2024 will be sent until **March 15**th, **2024**.

2. STAND

The exhibitor has the right to request a different stand size of the proposed, but the organizer does not guarantee its concession in case of non-availability of space.

Following the submission of the Application, the Exhibitor is not allowed to change the size of the stand.

Upon acceptance of participation, the organizer reserves the right to change the stand size for practical reasons, upon informing the exhibitor.

The location of the stands is appointed by the organizer.

3. CONTRACT - PAYMENT

Should the gallery be accepted for participation in the exhibition, the exhibitor will receive a contract which must be returned signed by **April 10**th, **2024**, while paying an advance of 30% of the total amount.

The balance will be paid in two installments:

PAYMENT: 30% of the total amount by May 10th, 2024.

BALANCE: 40% until June 20th, 2024.

No exhibitor will be able to settle on its stand before having paid the expenses.

4. CANCELLATION OF PARTICIPATION

In case of cancellation of participation, the Exhibitor does not have the right of refund of the paid amount.
